- the salary and the holiday allowance in the month of May
 the salary and the year-end bonus in the month of December

* in the month of January of each year the maximum amount that may be saved under the law per month is adjusted.

He/she authorises the salary administration of the university to transfer these amounts to his/her salary savings account with ING Bank in Enschede (**ING Bank 023/08**), which account will be subjected to the employee savings scheme regulations referred to above.
