## Roadmap

We would like to give all of you a quick overview of our projects and the general planned development in and around Mobility-Online as planned for 2024.

---

### Mandatory implementations

---

1. We will be implementing Blended Intensive Programmes - a short-term mobility abroad - in Mobility-Online starting in March / April.
2. Erasmus Without Paper (EWP) requires the implementation of Top-Ups regarding green travel and fewer opportunities as well as sharing the Transcript of Records (ToR) via EWP. While the implementation of the Top-Ups is almost completed, EWP did not yet make the requirements of the ToR functionality known, so there is no exact start date planned yet.


3. Data Cleaning - the permanent deletion of data from Mobility-Online. We are currently busy with the project team surrounding data cleaning to establish what type of data Mobility-Online holds, which legal periods for keeping the data apply to them and what the system facilitates in terms of cleaning. We expect to perform the first 'real cleaning' within Mobility-Online in the second half of the year.

### Projects based on user requests.

1. New steps in Graduation Standard where the student is required to review the entered information regarding the thesis topic, description as well as committee members prior to requesting his or her final presentation date. Status: ongoing
2. Merging of the two (incoming) placement pipelines into just one pipeline as to facilitate efficiency. Status: not yet started
3. Integration of ITC into the graduation pipelines. Status: investigating feasibility


### General maintenance and system development

1. Authorization checks
2. Improvements based on audits
3. BIV classification update
4. New layout / user interface
5. Connections with other systems (JOIN, REIS)
6. Reports in Mobility-Online (cleaning up, creating new, etc)
7. Replacing manuals with in-line help texts for each pipeline step




## Updating of Question marks

As some of you might have already noticed, the small question mark icon to the right of each pipeline step has turned from grey to black. This is the case because we have now filled the help text of each step in the various pipelines.



Simply click on the question mark and the help text will open in a separate tab. Here you will find additional information on which applications you find in this step and what actions are required from you, if any.
