A) Master Programme (Global and) European Studies (1 year, 60 EC)

The *curriculum* of the master programme (Global and) European Studies consists of six core courses of 5 EC each, an optional course of 5 EC and the master thesis of 25 EC.

Changes in this programme:

The course 201500144 *International Relations and Politics Framework* is changed to 202200252 *International Political Economy*. This is a small change in content and a name change. It is a one on one replacement.

The course 201500158 *Regulatory Design and Implementation Beyond the Nation State* is changed to 202200089 *Governance & Technology beyond the Nation State*. This course has significant changes and has another teacher. It is a one on one replacement.

The course 201500123 *Policy Design and Implementation (Beyond the Nation State)* is changed to 202200092 *Global Public Policy*. This course has significant changes and has another teacher. It is a one on one replacement.

A one on one replacement means you cannot have the 2021 and the updated 2022 course in your results, since they are for a big part aiming for the same learning objectives: they are seen as one course. It also means that your curriculum will be valid with either the 2021 or with the updated 2022 course. You do not have to do the updated version if you succeeded in the version of 2021. If you have questions about this, please contact the study adviser.

B) Master Double Diploma Programme Comparative Public Governance (2 year, 120 EC)

Master students can also choose (during the first semester) the two year master programme Comparative Public Governance that is offered by the University of Twente (The Netherlands) and the Westfälische Wilhelms-Universität Münster (Germany). This programme leads to the double diploma (a one year MSc in Twente and a two year MA in Münster). In this case students follow two additional semesters (60 EC) offered by the Westfälische Wilhelms-Universität Münster in the second semester and third semester. Then the fourth semester (next to the optional course in Twente) has a combined master thesis supervised by staff members from both universities.

Modules in Münster in the *second* semester: Integration Module Comparative Public Governance (10 EC), Core Module Political Steering (10 EC) AND Core Module Political Participation (10 EC).

Modules in Münster in the *third* semester Optional Module "Erasmus exchange" (30 EC) OR Optional Module "Free Electives" (12 EC) AND Optional Module "Internship" (18 EC).

Concerning the (*): Double degree students are allowed to shift their elective to another quartile when deemed useful. It is also possible to shift academic research to their second year when deemed useful. A useful scenario can be to find an elective in Q2 instead of Academic Research, and to follow Academic Research just before their thesis in the second year. Academic research is programmed in Q2 and Q4.
