Biography / Statement of Research, Teaching and Service

I am a specialist in international and comparative political economy, particularly financial stability, financial regulation and European integration. I am the author of two books in these fields: on monetary union (*Reshaping Economic and Monetary Union*, 2004), and financial market regulation (*Regimes of European Integration*, 2010) and the author of a third book manuscript on banking union (*Realist Europe: Power Politics and the Undersupply of Financial Stability in Europe*, under revision for Oxford University Press after the first set of reviews), plus articles in JCMS, RIPE, NPE and other journals, as well as grant-funded scientific reports. I intend to submit a completed book manuscript on power politics in global regulatory networks in 2015.

I have 14 years experience at all levels of university teaching, employ flipped classes and leverage technology to develop students into excellent analysts, have very good to excellent teaching evaluations, and am the primary developer of a highly successful Master Program in Regulation, which is core component for students from European Studies, Public Administration and Health Sciences, and of a bachelor module in company law and regulation, which the university's board of directors singled out as one of a handful that exemplify excellence in teaching in 2014. These efforts involve coordinating, managing and training other staff. My master students have a good record of being selected for respected Ph.D. programs. I have experience as well in Ph.D. supervision, primarily in a supporting role.

I am experienced in project management, staff mentoring, educational management, administration and committee work (responsibilities for budgeting at the level of €80 million / \$100 million per year, human resources (currently covering 465 employees), scientific strategy and educational development strategy, plus performance reviews of all staff below the level of dean), and committee chairing in all of these areas, which requires direct contact at the level of deans and the university's central board of directors. These service and leadership activities focus on developing, sharpening and improving on strategic choices in policy and personnel, enhancing performance, and generally improving information management, reporting and quality control.

I'm constantly looking for a new challenge to innovate and to test the limits of the possible. As facts of the real world change, as they often do in financial markets, in Europe and globally, so does the research and teaching, and academic management functions that I undertake. My next ambitions are to focus research more strongly on the development of global regulation and institutions, rather than just European developments, to study their impact on national public administration, and to devote more time to academic leadership, doctoral supervision and service as an associate professor.
