1.3 Capacities, tasks and responsibilities of the Examination Board

As laid down in the Dutch Act on Higher Education and Scientific Research (WHW, article 7.12), capacities, tasks and responsibilities are assigned to the Examination Board of ME/SET and is appointed by the dean of the Faculty of Engineering Technology (ET). Additional capacities, tasks and responsibilities of the Examination Board ME/SET are laid down in the Education and Examination Regulations (EERs) of the (BSc and MSc) ME programs and of in the EER of the MSc SET program. As such, the Examination Board determines whether a student meets the Final Qualifications (FQs) of the ME and SET programs and therefore can safeguard the quality of the diplomas of programs. The capacities, tasks and responsibilities of the Examination Board ME/SET include, but are not limited to:

- · quality assurance of exams test plans,
- appointment of examiners,
- decisions regarding requests of students regarding an individual course program, or a deviating course program, based on and in accordance with rules in the EER,
- · signing diploma's,
- establishing and monitoring Binding Study recommendation (BSA) of first year students,
- handling requests and complaints of students (see section 2.2),
- handling (suspected) fraud cases (see section 2.2).

1.4 Mandates

The Examination Board has delegated well defined tasks to other officials in the organization of the Faculty of Engineering Technology (ET) and the University of Twente (UT), to handle standard (student) requests, complaints and situations that require standard and quick decisions. Mandates are documented in writing and archived. All decisions made by mandated staff are presented and discussed by the secretary at the meetings of the Examination Board by means of a "decision list". All non-mandated decisions are made by the Examination Board.

1.5 **Documentation and archiving**

Minutes, agenda's, and other documents, such as mandates and decisions of/by the Examination Board are archived by the secretary of the Examination Board on the shared computer P-drive (server) of the University of Twente, with restricted access only for members of the Examination Board. Decisions of the Examination Board are documented either in the minutes of the meetings of the of the Examination Board or in the so-called "decision list" (see section 1.3). Also, this list is archived.

1.7 Improving the skills and expertise of the Examination Board

In 2019, drs. M. de Haan (external member of the Examination Board) enrolled in the "Senior Examination Qualification" trajectory (SEQ) aimed at, amongst others, members of the Examination Boards. The knowledge obtained by Mrs. de Haan will be used for quality assurance by evaluation of rules and procedures in place in the programs of ME and SET, as well as to continue the Board's process of test-quality assessments (e.g. by participating and working together with the other members of the examination board and the teachers on the evaluation of tests). Mrs de Haan successfully finished the trajectory in 2020.

2 ACTIVITIES OF THE EXAMINATION BOARD 2020

This section provides a brief overview of a few major advisory and policy-related tasks that the Examination Board, in addition to its regular tasks, fulfilled in 2020.

2.1 Meetings 2020

The Examination Board ME/SET had six meetings in 2020, namely on 10-02-2020, 20-04-2020, 15-06-2020, 27-08-2020, 26-10-2020 and 14-12-2020. Starting in April 2020, committee meetings have taken place on-line through MS TEAMS, due to governmental measures to fight the Covid-pandemic

2.2 Effects of the Covid-19 pandemic and decisions to mitigate its effects

It is no surprise that the Covid-19 pandemic also had (and still has) a large effect on how the Examination Board ME/SET shaped and performed her responsibilities (see section 1.2), in 2020. That is, some strict rules, as laid down, in, for example, Education and Examination Regulations (EERs) of the (BSc and MSc) ME programs and of in the EER of the MSc SET program, have been relaxed, in order to mitigate unreasonable effects (such as too long delays) on students, due to governmental- and/or or institutional measures (e.g. lockdown) to fight the spread of the Coronavirus. Rules were only "relaxed" when the Examination Board ME/SET could/can still safeguard the quality of exams and the diplomas of the programs. The Examination Board ME/SET decided to adapt the rules, as listed in table 1, only for the duration the Dutch government dictates educational and examination restrictions to higher education.

2.3 Student request, complaints and cases of fraud

In 2020, the Examination Board has processed multiple student requests, including but not limited to requests for extra examinations or resits, requests for an exemption and requests for a non-standard study-program. Table 2 provides an overview of the cases handled. This table also lists a number of fraud cases and complaints, which have been dealt with. For comparison, the table also lists the cases of 2019.

^{*} Some fraud cases involve groups of students, e.g. project groups. In those instances, a case is listed as one case in the table. So, the total number of students involved is larger than the number of cases. In 2020, 34 students were involved in 16 fraud cases. And in 2019, 25 students were involved in 5 fraud cases.

As can be concluded from table 2, the number of cases handled by the Examination Board in 2020, more than doubled, when compared to 2019. The latter is mainly attributed to the effects of the Covid19-pandemic on the study progress and behaviour of students.

The increase in fraud cases is caused mainly by on-line examinations, during which students cheated, at the start of the Covid19-pandemic. Therefore, after the first on-line examinations, the

Examination Board insisted on "physical" on-Campus exams in favour of on-line exams. Measures were taken to allow "physical" on-Campus exams in safe way to prevent the spread of the Covid19 virus. Whenever, "physical" on-Campus exams were not possible, measures to minimize the opportunities for students to cheat were taken (see section 2.2). Also, while grading exams, examiners put more effort in identifying fraud, typically occurring in on-line examinations.

The increasing number of (non-fraud) cases handled by the Examination Board in the previous years is also attributed to the trend that students are more assertive and "know where to find" the Examination Board for requests and complaints, etc.

2.4 BSc Mechanical Engineering at the VU in Amsterdam

In September 2019 the University of Twente and the Vrije Universiteit (VU) in Amsterdam, started a "satellite" BSc program in Mechanical Engineering at the VU in Amsterdam. The responsibilities if the Examination Board ME/SET also extents to the examinations, students, etc. of this program in Amsterdam, see the annual report of the Examination Board ME/SET of 2019 for details.

As both programs have the same ISAT code in CROHO, complaints etc by students in Twente and in Amsterdam are (to be) dealt with identically (of course) by the Examination Board ME/SET. However, the board of the VU was (and still is) more strict in interpretation of governmental Covid-19 measures than the board of the University of Twente in Enschede. For example, unlike in Enschede, no on-site exams were allowed in Amsterdam, and al examinations were "forced" to be taken on-line. This led to different rules and requirements for/between students in Amsterdam and in Enschede. The latter is undesirable.

2.5 Participation in UT Platform Examination Boards

The Chair of the Examination Board ME/SET participates in meetings of the University wide *Platform of Examination Boards*. Chaired by prof. dr. T. Bondarouk (chair Examination board of Behavioural Management Sciences, BMS) and prof.dr. A.A. Stoorvogel (Chair of the examination boards of faculty Electrical Engineering, Mathematics and Computer Science, EEMCS) this platform regularly discusses best practices of/for Examination Boards, as well as aims at harmonizing rules and guidelines of examinations and quality assurance, which overarch the various educational programs at the University of Twente. In 2020, the consequences of the Covid-19 pandemic dominated the agenda of the Platform meetings.

2.6 **Diploma's and cum laude**

Table 2 lists the number of students who were awarded a Bsc or Msc degree, as well as the number of students who graduated cum laude—i.e. a "with distinction" degree. As can be concluded from this table about 4% ME students (both BSc and MSc) graduated cum laude, whereas this percentage is 7% for SET students.

3 SELF-EVALUATION 2020 & OUTLOOK TO 2021

Each year the ME / SET Examination Board evaluates its own functioning and formulates aspects to work on for the next calendar year.

3.1 Self-evaluation 2020

Guided by drs. L. Chapel (Leonie), Educational Consultant of the Centre for Educational Support (CES), Centre of expertise in learning and teaching (CELT) of the University of Twente, the Examination Board ME/SET evaluated its own performance regarding w.r.t its (legal) tasks and obligations, in two sessions. It was concluded that the Examination Board ME/SET is "in control" of the examination quality of the ME and SET programs. A follow-up of this self-evaluation is planned for 2021, or 2022 if the Covid19-pandamic continues. Topics to address will include, whether or not to establish "signalling conditions" for examiners (lecturers), such that they will know when to inform the Examination Board about irregularities. These, as well as the findings of this evaluation were documented and archived (see section 1.5).

In 2020, the Examination Board ME/SET planned to statistically analyse the performance of foreign students, originating from outside Europe, as there are signs that these students underperform, when compared to European and Dutch students. *Due to the extra workload induced by the Covid19-pandemic for the* Examination Board ME/SET, as well as for the educational support units, this activity is postpone to September 2021. It should be noted here that data to base this analysis on is not readily/easily available from the software systems of the educational units. This is undesirable.

3.2 **Outlook to 2021**

In 2021, assuming the situation induced by the Covi19-pandemic will relax, the Examination Board plans to address the following:

- Continue the evaluation of tests and test plans in Modules of the BSC program ME, as was initiated earlier.
- Evaluation of the effects of the Covid-pandemic on the quality of exams and fraud cases. What can/did we learn? Which (changed) rules (see section 2.2) should be rolled back, or kept/retained?
- Based on the self-evaluation formulate concrete action points for the upcoming year(s), see section 3.1.
