

## Conditions for camping on the University of Twente campus:

We attach the following conditions to this permission:

### *General*

1. all instructions given by University of Twente staff members must be followed to the letter; the camping materials must be set up in such a way that the grounds remain easily accessible for motor vehicles in use by the University of Twente, Municipal Health Service, Fire Service and Police.
2. the following must be available at the camp site:
  - a. a first-aid kit (model A);
  - b. enough litter bins with lids;
  - c. enough and adequate washing facilities and toilets, with separate facilities for men and women.
3. people must camp in such a way as to make the site safe for both people and goods.
4. people must camp in an ethical and hygienic way.
5. the camp must not cause any inconvenience to its immediate surroundings.
6. the camp must not produce any music that is audible outside the campus.

### **Requirements regarding fire safety:**

#### *General*

1. All activities must take place in such a way as not to create any fire risk and to ensure that the spread of any fire which may start is limited.

#### *Keep the grounds free and accessible*

1. For the benefit of the emergency services, the site must have sufficient access points;
2. If the site is (temporarily) closed off, it must be possible for the entrance gate to be opened quickly by the fire service or by *the organizers*;
3. It must be possible for emergency vehicles to have unimpeded access, via an appropriate, obstacle-free emergency route, to any (temporary) structure/tent to a distance of no more than 40 metres from the structure.
4. An appropriate *emergency route* must:
  - a. be at least 3.50 metres wide;
  - b. have a clearance of at least 4.20 metres above the route;
  - c. have enough room in any bends to accommodate a fire engine;
  - d. be suitably paved so as to be able to support fire engines.

#### *Temporary camping facilities*

1. Temporary camping facilities are permitted, provided that:
  - a. tents are erected close together with a maximum of 1,000 m<sup>2</sup> (a single compartment);
  - b. there is at least 5 metres of free space between the compartments;
  - c. all camping facilities (tent, camper van, caravan, etc.) must be accessible by fire engines to a distance of 40 metres;
  - d. The distance between camping facilities (not tents) must be 3 metres;
  - e. it is forbidden to use liquid petroleum gas (LPG), commercial propane or commercial butane in LPG tanks, other than for the purpose of fuelling motor vehicles.
  - f. To make it possible to fight fires as soon as they start, firefighting resources, preferably a foam extinguisher, must be available and accessible at a walking distance of 50 metres. A central location on the site, such as lavatories, Reception or another key function, is ideal for this purpose.
  - g. in the event of a report to 112, the address must be clearly stated and the emergency services must be informed that people are sleeping at the site.
  - h. following a report to 112, University of Twente Security must be informed on the emergency number: (053-489)2222.

#### *Firefighting resources (NEN-EN2, NEN4001)*

1. The event site must include fire extinguishers which contain at least 6 kg or 6 l of extinguishing agent, are suitable for putting out class-A, -B and -C fires and are ready for immediate use;
2. A small fire extinguisher must be clearly visible and easily accessible, ready for immediate use and in a good state of repair.

#### *Litter*

1. Litter must be collected daily in secure and easy-to-close containers.
2. The contents of the ash collectors may only be disposed of in non-flammable containers with lids.
