## Module 2 Smart Environments improvements and manual

The module is currently ongoing and the programme committee believes that discussion of this matter should wait until the evaluations.

The following should be included at that time (action Poel):

- Minimum grade for sketching is not listed
- Include the regulations pertaining to resits (sketching) in the manual

There is also a discussion about resits. Determine what the results throughout the year are like and then offer an additional chance.

#### 5. Module 4 Art Impact and Technology

Poel summarizes briefly. The programme committee believes that these are observations rather than a plan for improvements. Poel wants to contact the coordinator regarding this issue; however, module 4 does not have a coordinator yet.

This module remains "troublesome" because of its incoherence. However, the module does score well among students.

# 6. Module 8 Data from the Source to the Senses

The module as a whole has scored well during the evaluations. Compliments extended to the team.

#### 7. User Centered Design (verbally introduced by Ter Stal)

Ter Stal takes the floor. This subject is not innovative for CreaTe students. It is mandatory to conduct research in pairs, for which one Dutch student is paired with a foreign student. The videos pertaining to this research are in Dutch while the subject is in English. As a result, the

Dutch students tend to do most of the work. Because groups have been formed, there are reasons not to drop the subject.

The evaluations for this subject were conducted in the classroom. One student was asked to list a positive aspect, while others had to list negative points. Identical answers were not allowed. This subject has no added value for CreaTe students.

Ter Stal will put matters in writing and hand this to Schaafstal. Schaafstal will discuss the issue with the teacher/programme. (action Ter Stal/Schaafstal)

# 8. Evaluations HMI master subjects HMI (verbally introduced by De Meij)

De Meij says that, in the past, evaluations were conducted for all subjects. To this day, however, he has not received any more evaluations. This is probably due to the fact that master subjects are evaluated in general and teachers can request to see these evaluations. Faber will contact Romkema to clarify the matter. (action Faber)

# 9. Spearheads
