Instead, the papers will be summarized and critically discussed (5 minutes) by a discussant (see below) with regard to the extent with which they address the central question of the panel and the related NIG research colloquium:

Is it possible to outline the features of a good governance system and if so, what are the constitutive elements and what helps to establish and/or improve such a system?

The author of the paper then has 5 minutes to respond, followed by a general discussion of 10 minutes per paper (or a joint discussion on all papers within the sub session of about 30 minutes).

The panel will start with a very brief introduction of the topic and the program by the organizers. The last session of the panel is reserved to discuss future plans and draw conclusions from the panel discussions.
