3. Toelichting/samenvatting:

In June 2016 the name of the programme changed from Telematics into Internet Science and Technology (M-IST) in order to reflect the content of the programme better and to attract more students. The name change did not result in an increase in intake. There are currently 11 students in the programme in total (across the years). Maintaining M-IST as a separate master is not viable, whereas turning it into a fourth specialization of the master Computer Science (M-CS) reduces complexity and overhead, increases transparency, and may very well actually increase the enrollment of M-IST.

According to the Dutch act on high education, an institution has to terminate the registration of a degree programme before the 28th of February of the calendar year preceding the first study year in which the enrollment of the programme stops. That is why the University Council has to agree on the intended decision of the executive board in February 2019 in order to stop the enrollment per September 2020.

The university will guarantee that current students are able to graduate within M-IST. A reasonable period to finish a degree programme is the nominal study time plus one year. This means that accreditation must continue until 31 August 2023. Current students will be informed about the termination of M-IST.

Because termination of a degree programme implies adaptation of the Management and Control Regulation (in Dutch: Beheer- en Bestuursreglement), the University Council is asked to approve the intended decision of the Executive board.

4. Besluit CvB:

The Executive Board takes the intended decision to terminate the Master's programme Internet Science and Technology and stop the intake of students per September 2020. This intended decision will be submitted to the University Council for approval.
